Good news! Another group has added you as a recipient on their ActBlue contribution form. They're leveraging our [Tandem Fundraising](#) feature to fundraise jointly with other groups. Donors' contributions are split evenly between you and the other groups listed by default, though they can also customize how much they give.

What's next?

- 1 Get started.** If you've been added to a Tandem form, it means your campaign or organization already has a fundraising Dashboard set up with us! Log in to get started, or visit help.actblue.com for help accessing your Dashboard.
- 2 Worried about compliance?** Never fear – the Tandem form will automatically configure to adhere to your group's contribution rules and include any disclaimers.
- 3 Monitor performance.** Go to the **Contributions Form** tab of your Dashboard and click **Managed by other groups** to see the form you were added to and how much has been raised on your behalf.
- 4 Download reports.** By default, you'll be able to access the fundraising data for contributions donors make to you through another group's Tandem form. Download a report and start learning about your new supporters!
- 5 Thank and connect.** Remember to send a thank-you email to your new donors! You can use this opportunity to showcase your mission or share other ways they can engage with your work.
